OSHA has made it clear that new, temporary, and visiting workers must be brought up to speed on HazCom compliance. OSHA has maintained for many years that new employees, even ones brought aboard for the short-term, need to be trained on HazCom. In a July 9, 2015 enforcement directive, OSHA also further clarified that businesses with multi-employer worksites must have a system in place for providing chemical safety information to all on-site employees, and for providing access to SDSs. OSHA maintains that staffing agencies and host employers share control over temporary employees and are jointly responsible for ensuring they are informed and trained on workplace chemicals.
