Putnam County Memorial Hospital in Unionville, Missouri — located near the border of Missouri and Iowa — has been serving the medical needs of their local population since 1963. The acute care facility features 25 beds; 15 beds on the med surge floor and 10 beds in a behavioral health unit. The hospital features ER, Lab, Radiology, Respiratory, Physical Therapy, Cardiac rehab/stress testing, and outpatient procedures/surgery departments, as well as an outpatient psychiatric service called Senior Life Solutions.

Also associated with the hospital are a Specialty Clinic, a Rural Health Clinic and a downtown Physician Clinic. Bringing all of these services to a small community gives the hospital a unique set of challenges. To keep its mission of service alive, Putnam County Memorial Hospital must manage costs wherever possible and streamline work for its employees.

Lisa Schmidt has been the hospital's director of purchasing for the past five
