Since the 1950s, Ward Memorial Hospital has been providing vital healthcare services to the citizens of Western Texas. Located 30 miles west of the Midland-Odessa metropolitan area, the 25-bed facility serves not only local residents but also the communities of oilfield workers located throughout the region. It is a Level IV Trauma Center and employs 100 physicians, nurses, and staff members.

Like many small, standalone hospitals, Ward Memorial Hospital often calls on employees to wear multiple hats in order to meet the needs of their patients in an efficient and cost-effective manner. When it comes to chemical management, for many years, Ward Memorial Hospital relied on binders full of paper safety data sheets to satisfy compliance and right-to-know requirements. However, when Sara Davy, RN, LP, assumed responsibility for the hospital's chemical management in 2015, she began looking for a way to make the process more streamlined and less burdensome.

"For employees in my situation at smaller hospitals, there are never enough hours in the day," explains Ms. Davy. "Beyond being a nurse, my responsibilities include managing safety, trauma coordination, and infection control. My top priority is always keeping patients and employees safe. Thus, I'm constantly looking for ways I can be more efficient and save time, while still providing the highest-quality care to all patients of the hospital."

Ms. Davy explains how finding the right solution started with a sales call.

"When I took over safety, I found that — like most small hospitals — we didn't have a strong, centralized process in place for tracking safety data sheets," says Ms. Davy. "We also didn't have an efficient system for ensuring we had the most current versions. I had to physically locate people in different departments and make them do updates. That changed after I got a sales call from VelocityEHS. I actually had to pass the first time around, but when

they called a second time in March of 2016, we had the funding in our budget and we made the decision to adopt VelocityEHS Chemical Management."

Ms. Davy reports that making this change resulted in immediate improvements to the hospital's management of safety data sheets.

"Right away, it saved us so much time," says Ms. Davy. "We didn't have to go through and manually update the SDSs in each binder location anymore. It also made the transition to GHS less stressful. I really like not having to worry so much! I also like that you can go through and catalog each item and then run reports for NFPA information to see which corresponding placard you can post. That function saves a lot of time too."

"Beyond the chemicals people expect a hospital to have, remember that we also use a whole lot of cleaning supplies which need SDSs," says Ms. Davy. We've never had a problem locating an SDS using the VelocityEHS system. Whenever we need it, it's been there."
